


ESG members tabled at the Coffee & Consent event hosted by the Green Dot Program. Students were educated on healthy relationship and consent!

# Madison County Community Health Assessment

The EKU Public Health faculty and several Public Health students partnered with the Madison County Health Department (MCHD) to conduct a county wide community health assessment. This consisted of a Health and Safety Survey that was administered to the public from October 31st through December 6th. Two versions of the survey were created, an English version, and a Spanish version. Data based off of the survey was then collected to identify what community members feel are the top health issues within Madison County. This information will be used by the MCHD and EKU to facilitate community wide meetings and then aid in identifying creative interventions for the top health issues in the county. Students received instruction on the Role of Local Health Departments and the Kentucky Department for Public Health in Disease, Outbreak Investigation and Disaster Response, use of the Incident Command System (ICS) in Public Health Emergencies, the Basics of Field Epidemiology and Outbreak Investigation, and Public Health Interviewing Techniques.

#### Letter from Department Chair

Greetings Public Health students, alumni, and friends. Normally each year I write a letter that is included in the newsletter that highlights many of the events, and activities of the year. However, this year my remarks are a little different. The emergence of the COVID-19 pandemic required each of us to adapt to numerous changes to flatten the curve. As I write these remarks, the US is nearing the total of 1 million people infected, and almost 100,000 fatalities. Our thoughts and prayers are with all individuals and families impacted.

The spring semester that many of you remember on the Campus Beautiful changed dramatically in March. EKU made the decision to change all courses to an online format in response to the pandemic. I want to express my sincere gratitude to all of the faculty that worked so diligently to quickly move courses to an online format in about 10 days to foster a successful conclusion to the spring semester. I know this presented many challenges for our students to complete the coursework remotely. However, I was so impressed by the efforts of the students and faculty to adapt to the new format.

The events of the past few months have reinforced the importance of Public Health at all levels. I would be remiss if I did not recognize all of our alumni and partners that were working on the front lines in response to the pandemic. In addition, I know many of our current students and recent graduates have assumed roles in response to the pandemic.

The department is working on plans for the 2020-2021 academic year. We do not know exactly what that will look like, but we look forward to another successful year. One thing that we know is already scheduled is our reaccreditation site-visit. In November, the Council on Education for Public Health (CEPH) will be on campus to meet with faculty, students, and stakeholders. A special thank you to the Dr. Michelyn Bhandari, program coordinator for her efforts in leading the faculty in the completion of the self-study process. Her steady leadership and the commitment of the entire faculty has fostered numerous curricular changes to make sure that all of our students are prepared to meet the needs/expectations within the discipline.

As a program alumnus, I was fortunate to have had the opportunity to be taught and mentored by several of the now retired faculty in the department. I know each of you can easily think about the professors that have made a significant impact on you. For me, the three faculty that had the biggest impact were Dr. Don Calitri, Dr. Les Ramsdell and Dr. Merita Thompson. Each were dynamic teachers, and went above and beyond to help students be successful. In December 2019, we learned of the passing of Dr. Les Ramsdell. Our sincerest condolences go out to his wife Jan and the entire family. I was blessed to have Dr. Ramsdell as a faculty member in several courses, and sincerely appreciated all the times that I dropped into his office to talk about PH issues, career plans, or life in general. He was truly a consummate professional, and example that we also should emulate. I hope each of you are also able to make the same kind of impact on others as Dr. Rasmdell did for so many of our alumni. The department previously established the Baugh, Calitri, Ramsdell and Thompson Scholarship if you would like to a make a donation in memory of Dr. Rasmdell.
